



Planning Commission considers new manufacturing utilities building

On August 27, the Planning Commission considered an application for a new utilities building.

501 Vandell Way:

Allergan Inc., a pharmaceutical manufacturer, had applied to replace an existing site utilities building. The new building would be smaller, but be three stories high. The remaining open ground would remain fallow at this time. The building would have three of four walls consisting of air-intake louvers, to assist in cooling the equipment inside.

The Commission discussed potential noise and light emissions at length. Staff had not focused on these issues, and the applicant had provided no firm data on expected emissions. The Commission's concern was to prevent an increase in noise and light over current conditions at the site. The existing building has concrete walls, and the equipment inside is scheduled for replacement, preventing useful

comparison of emissions with those of the proposed building. The proposed louvers would need to be angled such that light from within the building would be aimed downwards, toward the parking lot. And the sound level coming through the non-solid walls would need to be no more than about the volume of a loud conversation when measured at the edge of the property.

The Commission approved this application, with the condition that the proposed building design pass independent analyses of both light and noise emission levels.

In-N-Out Burger: Of the seven Commission seats, one seat is vacant, owing to Commissioner Rich's recent resignation. Commissioner Ostrowski was absent from the meeting, and Commissioners Ching and Buchbinder recused themselves from this item. Owing to the lack of a quorum, the item was continued until the Commission's next meeting on September 10.

Antique Autos in History Park

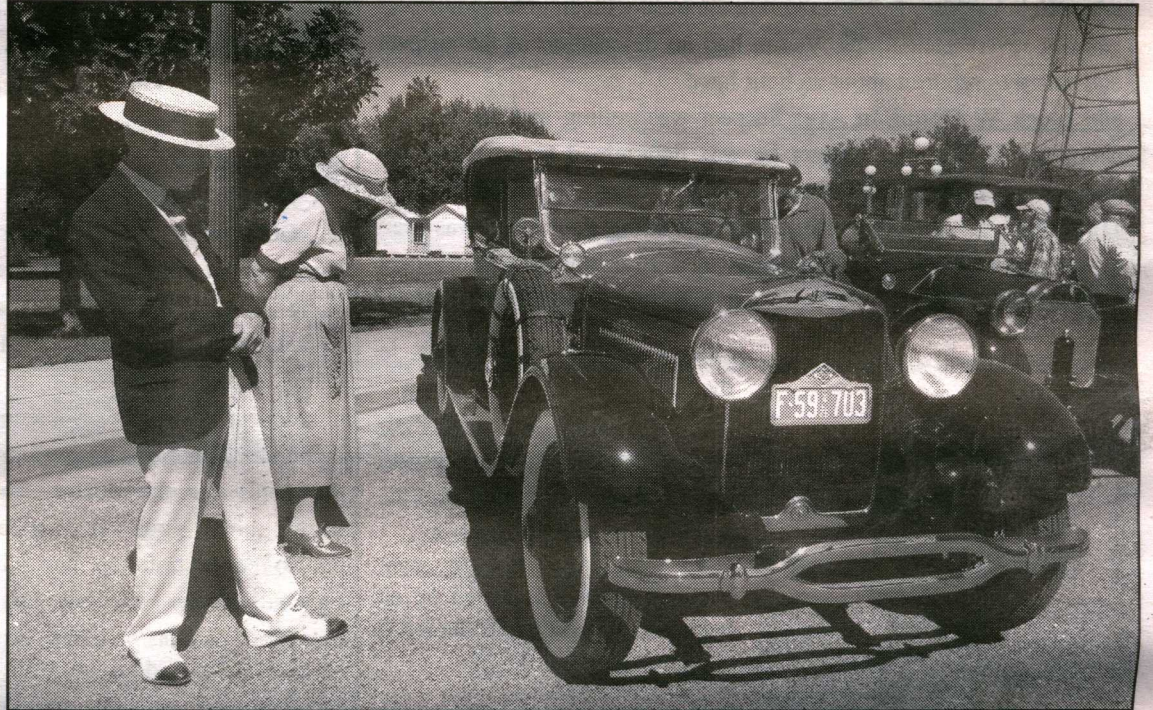

Commemorating the end of WW II: Spirit of 45 celebration

World War II or the Second World war ended in the year 1945. It was a heady time for many. The end of WW II was universal, more or less with Japan's "surrender." (Actually the Emperor of Japan did not use the word "surrender" but said Japan must "bear the unbearable"). When the war began depends on the country. For China the war may have said to begun when Japan invaded Manchuria in 1931. However, at the time Manchuria was not fully integrated into the country of China. The war between China and Japan did not officially begin until 1937. At this time Japan, Germany and Italy had a defensive pact against the Soviet Union. Such an agreement did not prevent Nazi Germany from briefly helping Nationalist (KMT) ruled China, led by Chiang Kai-Shek. So it is no accident that the reenactors of the Nationalist Republic of China (ROC) wore German style helmets at this event. In the early part of the

Second Sino Japanese War, the Chinese soldiers did indeed wear German style helmets. The war in Europe began in 1939 with the British and French going to war with Nazi Germany. The Soviet Union had a non-aggression pact with Germany and did not officially take sides. With the German invasion of the Soviet Union, the Soviet became allies of the British, the free French and unofficially the United States. With the Japanese bombing of Pearl Harbor, along with the German and Italian declaration of wars on the United States; the United States officially entered the war against both Germany and Japan. The Soviet Union and Japan maintained a neutrality pact until 1945.

Reenactors from the home front as well as the regular military were represented at the event. You may have seen members of the U.S. Army, Navy and Army Air Corp portrayed in the movies. Reenactors from

those branches of the service were there, but there were also people dressed as members of the British Women's Land Army and the British Home Guard. The Home Guard, was composed of people too old or too young to serve in the regular British Army. Their purpose was for the initial home defense of Britain. Their story was depicted in the situation comedy "Dad's Army." The Land Army was composed of women who served in area of food for the British war effort. These women wore hats and had green sweaters. On the U.S. home front, there was someone dressed as a police officer. He carried a baton and a restraining device called "nippers" which were sort of like handcuffs. The nippers were two short metal rods connected by a chain. According to one web article these restraining devices were used in New York until 1958.

It was interesting talking to the various reenactors. One

could get very interesting tidbits of information. The Republic of China (ROC) soldier reenactors, had a variety of equipment. As stated before they wore German helmets. Not all of them wore the helmets. One of them had a straw hat, which this writer mistook for a Vietnamese hat. The reenactor explained that style of straw hat, was the type favored by Sun Yat Sen (Sun Zhong Shan), the "Father of China." Among the weapons in their collection was a Czech machine gun, a Czech VZ 24 rifle. One of them commented that Czech weapons were the best, even better than German weapons. Since Czechoslovakia was the country in existence at the time, one wonders if those weapons were made in the Czech part or the Slovak part of the country. Perhaps the Slovaks may argue that Slovak weapons are the best. Also included in their arsenal was a Yugoslav made Mauser. It was interesting to see this tribute to the ROC soldiers. In his

book AMERICAN SHAOLIN, Matthew Polly mentions, in passing, that while the Chinese Communists boasted of fighting the Japanese, it was actually the Nationalists who took the brunt of the Japanese attack. One of the reenactors, who was originally from Mainland China said that was indeed true. But when he was in Mainland China, he was given the propaganda line. This writer has no idea how many of the ROC actors were from Mainland China (PRC) and how many were from the Republic of China (ROC or Taiwan). One of the reenactors was dressed as a member of the United States Army Air Corps (the Air Force did not become its own entity until later). He mentioned that officers were expected to pay for their own uniforms. Unlike enlisted personnel they did not get issued a uniform. He also was nice enough to point out a reenactor, whose father was a Tuskegee Airman. This writer's

uncle was also a Tuskegee Airman. It was nice to be able to meet this daughter of a Tuskegee Airman and exchange notes.

Also at the celebration was an event commemorating the air war in China. There were two lectures held at the replica firehouse. The first dealt with the Chinese and Chinese Americans who served with the Flying Tigers. Among the attendees was 95-year-old Henry Lim, who was part of the ground crew who kept the planes flying. His son, Sheldon was also in attendance. Sheldon's book IN THE SHADOW OF THE TIGER was a wealth of information. In addition to chronicling the history, the book also contains contemporary

reports from a bilingual Chinese / English newsletter. There was mention of poison gas used by the enemy to capture the Chinese city of Changsha. When this writer mentioned his discovery of the use of poison gas, in that particular newsletter, to two senior aged Chinese Americans, that was old news to them. The newsletter did not view the Japanese as fellow Asians, but referred to them as "Japs." The second lecture was by Ann Lee, whose uncle from China, got killed in accident. During World War II many Chinese Air cadets came to the United States for training. Ms. Lee shared the stories of the cadets who got killed in accidents and never made it home to China.
